Office of President:

- a. Serves for a term of two (2) years as a voting member of the Board. Can be elected to a maximum of two (2) consecutive terms. There is no limit on the overall number of terms.
- b. Oversees all business affairs of RMC.
- c. Sets the agenda for the meetings.
- d. Chairs all Board meetings.
- e. Can call emergency Board meetings as necessary.
- f. Is authorized to sign deeds, leases, mortgages, bonds, contracts, or any other instruments that the Board has authorized to be executed, except when another officer is designated to sign by the Board.
- g. In the event of a Board vacancy, appoints any qualified RMC member to fill the unexpired term. The appointment is subject to the Board's approval at the next scheduled meeting.

- d. Shall report the financial status of RMC at each regular Board meeting, and prepare the annual report to the Membership meeting
- e. Collect and deposit all contributions and membership dues in the name of RMC in such accounts as shall be designated by the Board.
- 3f. Establish and maintain insurance policies for RMC as directed by the Board.
- g. Oversee preparation and submission of tax returns as required by federal and state law.
- h. Record membership dues and maintain membership lists.
- i. Manage and file all documents for maintenance of not-for-profit status.
